Committee members felt that passing judgement on the transferability of courses was not within their purview and, at this time, declined to make recommendations related to the courses in question. The committee did, however, make the following suggestions:

1. That Tom Wynn be contacted regarding the possibility of CAP consideration of the request. (Discussion with Tom indicated that he felt the CAP could consider the student's request for transfer of some of all of the rejected courses.)
2. That the Dean be consulted and, perhaps, invite Jim Tidwell to attend the next C & R meeting to discuss transfer guidelines, the reasons for rejection of the courses in question, and why the request was made by A & R for college level action.

(I spoke with the Dean and he suggested that the course descriptions be sent to the Dean of the School of Education for review and recommendation.)
