# CURRICULUM AND REQUIREMENTS COMMITTEE MINUTES Meeting of May 11, 1977

Members present: Dean Ballantyne, Drs. Eley, Fernandez, Null, Tregarthen; ex officio: Dr. Blade, Mr. Burns

#### I. Old business

- a. The minutes of the meeting of 4/13/77 were amended to show that LSPN 345-3/346-3 had been changed from LSPN 300-3 and that the title was (and is) Teatro Chicano. The minutes were approved in this revised form.
- b. LPSC 103-2 Politics as Practiced in Colorado was approved in its revised form with one correction: a two credit hour class must meet for 26 clock hours rather than 20. Prof. Fernandez wished to go on record as recommending to Prof. Klotz that minority parties and politics be covered in the course. Prof. Fernandez would be willing to suggest potential sources of information and guest speakers on this topic.
- c. Discussion of the committee membership question
  It was resolved that Mr. Burns should draft a proposal to be submitted
  to the LAS general faculty at its next meeting, and to include the
  following points:
  - 1) The Curriculum and Requirements committee is an <u>advisory</u> committee to the dean of LAS.
  - 2) The committee has no authority to consider graduate level courses.
  - 3) Effective participation requires longer terms than two years. Three year terms are therefore proposed.
  - 4) To maintain the staggered replacement provision of the original proposal: (a) three current members of the committee would serve one additional year and (b) two new members would be elected in September 1977 for 3 year terms.
  - 5) It is proposed that the three members who continue to serve for one additional year be Eley, Fernandez, and Tregarthen.
  - 6) The provision that the committee members represent the "humanities, natural sciences, and social sciences" should be retained. Members of all departments would therefore be eligible for election in September 1977.

### II. New business

- a. New courses
  - PES 150/350-3, 151/351-3 Intro to Energy Sciences I,II/ Methods of Energy Sciences I,II
     PES 155/355-1 Special Project in Energy Sciences Following discussion in which it was noted that the courses may not be repeated for credit in the summer format, the courses were approved.
  - 2. LBIO/LCEM 151-4, 152-4 Environmental Science I,II

    Tabled. Further information is needed concerning the mechanism of the interdepartmental cooperation involved and the specific demands on resources (e.g. lab space), faculty time, etc.) which the proposal implies.
